between DSMZ GmbH and a the receiving culture collection Collection de l'Institut Pasteur (CIP)

1. **Research purposes only.** Biological material may only be used for research purposes and is not for use in humans (including food, cosmetic, or other preparations) or for clinical or veterinary purposes.
2. **Conditions of exchange.** Strain exchanges are carried out to further the understanding of biological diversity, to provide long-term security of strains, and to mutually benefit the receiving and sending culture collections. Strain exchanges must be reciprocal and bilateral and are at the discretion of the DSMZ GmbH management. The receiving culture collection must have similar terms and conditions including that strains can only be used for non-commercial research purposes and that customers cannot subsequently distribute strains purchased from the receiving culture collection.
3. **Commercial use is prohibited.** Biological material purchased from the DSMZ GmbH cannot be used for commercial purposes. Commercial use of products is defined as using the material directly for the purpose of profit generation. Commercial use is not income to the receiving culture collection generated from the distribution of these exchanged strains. Income generated from the sale of exchanged strains should cover incurred costs but not be excessive. Individual requests for commercial use of microorganisms can be considered on a case-by-case basis by DSMZ GmbH management, in which case the receiving culture collection should direct their customers to contact the DSMZ once commercial use is anticipated.
4. **Nagoya Protocol compliance.** In the microorganism and plant virus catalogues, under "Nagoya Protocol Restrictions", some strains have associated files available for downloads. These strains are excluded from strain exchanges. Furthermore, any strains covered by a depositor-originated MTA or depositor notification are excluded from strain exchanges.
5. **Catalog listings.** The receiving collections' catalog should in some way acknowledge the DSMZ GmbH as the source of the biological material and post the associated DSM strain number.


